Date	Description
October 22, 2024	<ul style="list-style-type: none">- Registration OPENS at the rate of \$400 per team.- Rules are available upon confirmation of registration <i>and</i> payment.
November 20, 2024	<ul style="list-style-type: none">- Registration CLOSES- Late Registration OPENS at the rate of \$500 per team.- Q&A Period BEGINS
November 25, 2024	<ul style="list-style-type: none">- Late Registration CLOSES- 2024-2025 CBMMTC Problem available for registered competitors
December 2024	<ul style="list-style-type: none">- Q&A Period ENDS

Registration Timeline/Steps

1. On October 22, 2024: Competitors will navigate to **NBLSA Website / Wild Apricot**
 - a. Competitors will fill out **Wild Apricot Registration Form**
 - b. Competitors will choose **payment option**:
 - i. Immediate Payment
 - ii. Invoice Payment
2. After Registering on Wild Apricot: Competitors will submit a **Registration Packet** and **fill out Google Form by the end of the Registration Period**
 - a. Competition Registration Form
 - b. Letter of Good Standing from University/Registrar
 - c. Local NBLSA Chapter Letter
 - d. Copy of Remitted National Membership Fee
 - e. Copy of Regional Convention Registration*

Registration Timeline/Steps cont.

3. After confirmation of registration and payment: CBMMTC Director will communicate to Regional Chairs/Directors the **CLEARED TEAMS**
 - a. CLEARED TEAMS Information will be uploaded to **CBMMTC Master School Registration List**
 - b. Regional Chairs/Directors will share with CLEARED TEAMS the **2024-2025 CBMMTC Official Rules**
 - c. Regional Chairs/Directors will update **Master School Registration List** to indicate **Rules** have been distributed
